- LEF FY25 grants are \$50,000, two-year general operating support grants, paid in two equal annual installments of \$25,000
- The Latino Equity Fund does not provide grants to individuals, nor does it provide funds for endowments, fundraising drives and events, retirement of debt, operating deficits, projects that directly influence legislation, political activities or candidates for public office.
